

Metric Setlist PRIZE DRAW TERMS AND CONDITIONS

Promoter's decisions are final and binding in all matters relating to the **Metric Setlist** Prize Draw; referred hereafter as the "Prize Draw".

Prize Draw Entry Period: Prize Draw begins at 1:00PM EST on the 15th of October, 2018 and ends at 10:00AM EST on the 25th of October, 2018 ("Prize Draw Entry Period").
